# Building & Vehicle Security Plan

## Building Security:

Panic buttons will be in the office.

Cameras with 24 hour battery power to provide live picture views of the outer perimeter and to eliminate blind spots inside the building.

Setronics Electronic Systems will install our maintenance video surveillance system. Acadian Central Monitoring system will monitor panic buttons and reports when an alarm is reported.

Alarm Systems monitors the Intrusion System through the Internet and will maintain a backup system.

Any incidents will be reported to local law enforcement and the Commission

Cannabis products will never be stored at the Taunton locations.

## Registration

Each customer will have to registrar online or in-store. Their address and state ID must meet state regulations before any orders can be placed.

Legal Greens will not delivery cannabis products to an area restricted by the state regulations.

With every delivery, the customer must present a valid form of ID matching the delivery information, to the delivery driver. This will prevent anyone under 21 receiving cannabis.

## Delivery Process

Delivery vehicles will have two drivers, cameras will eliminate blind spots to provide live picture views of the outer perimeters and inside of the vehicles.

Customer submits online order; receives notification via SMS/text message that the order has been placed. Dispatcher receives an alert that an order has been placed online. Dispatcher confirms the order, customer receives an SMS message that the order has been received.

All orders will be fulfilled and pick-up at a licensed marijuana store. All canceled orders will returned to the licensed marijuana store. Debt and cash will be the only form of payments. Routes will be randomized with each delivery.
